We do not actively source any personal data from publicly available sources and/or from third party

data vendors. However, if this does occur, we will ask for your consent to

retain such information as maybe necessary to better serve you. We may use information that you provide:

- To register you with our website or related services and to administer it;
- To deal with your enquiry which may include contacting your directly and supplying quotations and further information about our services.
- To send you newsletters if you have opted in to receive them;
- For assessment and analysis, e.g., marketing, customer and product analysis, to enable us to review, develop and improve our services.

Any external links that you may visit from our website are not our responsibility. Once you click on a link to an external site it will be subject to that organisation's privacy policies, and not ours.

If you go on to become a client of Oak House Workspace Limited, we shall hold your data for the duration of your contractual period or no less than 1 year . The provision of data in this instance is a contractual requirement.

3. Cookies
